

**SHIACOAA

**HOSTING:** Due to the ongoing Covid 19 pandemic, the meeting was conducted and attended remotely via Zoom.

**NEW BUSINESS:** While District 10 traditionally hosts the February CMIA event, it will be conducted in 2021 via Zoom because of the ongoing pandemic.

There followed a group discussion about the importance of observing the AA traditions during the pandemic and the challenges it is presenting, such as compliance with health department and meeting site guidelines required to prevent viral spread. AA has successfully functioned in the district for 70+ years and observing the traditions is a vital component in maintaining the unity of the fellowship and the reputation of AA as a whole.

**Bill D. suggested and the group agreed to present a Virtual Workshop on the Traditions. It will be a “BYOD” (Bring Your Own Donuts) meeting and is scheduled for Saturday, February 13, 2021 at 2pm. A panel of four AA members will give brief presentations followed by a question and answer period, and lunch will be “BYOBB” (Bring your own Brown Bag). Details will be discussed during the January District 10 business meeting and all members’ input is welcome. Zoom information to access the meeting will be posted on the SHIACOAA.org website.**
