

**SHIACOOA**  
**DISTRICT 10 BUSINESS MEETING MINUTES**  
**SEPTEMBER 11, 2015**

**HOSTING GROUP:** CHRIST EPISCOPAL CHURCH, 120 GOODHUE STREET, OWOSSO, MI.

Meeting called to order at 6:06 p.m. by Chairman Larry D. Larry opened the meeting with a moment of silence followed by the Serenity Prayer.

He will not publish it until the errors have been corrected and the goal is to have it up and running by Monday, September 14, 2015. Brian asked everyone to check it out at that time.
